A SPECIAL ORDINANCE AUTHORIZING THE CITY OF YONKERS TO ACCEPT GRANT FUNDING FOR THE NATURALLY OCCURRING RETIREMENT COMMUNITY (NNORC) PROGRAM IN THE AMOUNT OF \$15,682 AND AMENDING THE CITY OF YONKERS GRANT BUDGET FOR FISCAL YEAR 2025-2029

The City of Yonkers hereby ordains and enacts:

Section 1: The New York State Office for the Aging, has awarded the City of Yonkers, acting by and through the City of Yonkers Office for the Aging (the "City"), the Neighborhood Naturally Occurring Retirement Community ("NNORC") grant in the amount of \$15,682.00 for transportation services for five years.

Section 2: The City will provide matching funds via vehicle maintenance.

Section 3: The Mayor of the City or his authorized designee is hereby empowered to execute any and all instruments and take such other actions as may be necessary to effectuate the purposes hereof.

Section 4: The City's Grant Budget for fiscal year 2025-2029 is hereby amended by increasing revenues and appropriations as follows:

RESOLUTION AUTHORIZING THE ADOPTION AND PUBLICATION BY THE CITY COUNCIL OF THE CITY OF YONKERS OF THE DETERMINATION AND FINDINGS (AS DEFINED BELOW) UNDER SECTION 204 OF THE NEW YORK EMINENT DOMAIN PROCEDURE LAW CONCERNING THE PROPOSED CONDEMNATION OF CERTAIN REAL PROPERTY CONSISTING PRINCIPALLY OF A LEASEHOLD INTEREST ON ONE PARCEL, IN CONNECTION WITH THE PROJECT (AS DEFINED IN THE DETERMINATION AND FINDINGS)

WHEREAS, the City of Yonkers (the "City") is a municipal corporation with authority, pursuant to subdivision 2 of Section 20 of the General City Law of the State of New York, as amended (hereinafter called the "Legislation"), to take real property, either within or outside the limits of the City, required for any public purpose; and

WHEREAS, the City Council of the City of Yonkers (the "City Council") desires to exercise its power of eminent domain, if necessary, for the "acquisition" of certain "real property" as such quoted terms are defined in the New York Eminent Domain Procedure Law (the "EDPL") located in the City of Yonkers, Westchester County, New York comprised of a leasehold interest held by All County Bus, LLC, located at 76 a/k/a 70 Fernbrook Street a/k/a 8 Water Grant Street, City of Yonkers, Westchester County, New York and identifiable as Section 1, Block 615, Lot 1 on the Tax Map of the City of Yonkers, all in connection with the Project (as defined in the hereinafter defined Determination and Findings); and

WHEREAS, in accordance with the EDPL, the City Council conducted a duly noticed public hearing on March 25, 2025 at 6:30 p.m. to inform the public and to review the public use, benefit or purpose to be served by the Project, the proposed location of the Project and its general effect on the environment and the residents of the locality where the Project is proposed to be constructed and whereat, the public was provided an opportunity to provide any comments (the "Hearing"); and

WHEREAS, by Resolution No. 196-2024 adopted prior hereto on December 10, 2024, the City Council, in accordance with the EDPL and pursuant to the New York State Environmental Quality Review Act, Article 8 of the New York Environmental Conservation Law and the regulations promulgated thereunder at 6 N.Y.C.R.R. Part 617 (collectively referred to as "SEQRA"), issued a Negative Declaration determining that the Project will not result in a potential significant adverse impact to the environment and thereby satisfying the applicable

requirements set forth in SEQRA as necessary; and

WHEREAS, the City Council, having considered the foregoing, now desires to adopt and publish the Determination and Findings in accordance with the EDPL and any applicable laws, rules or regulations.

NOW, THEREFORE, BE IT RESOLVED that the Yonkers City Council, pursuant to Section 204 of the EDPL, hereby (i) adopts the determination and findings in the form presented at this meeting with such changes as approved by counsel to the City (the "Determination and Findings") as more fully set forth in Exhibit A annexed hereto and made a part hereof and (ii) authorizes its members, officers, employees and agents of the City (including Corporation Counsel and special counsel to the City) to (A) publish a brief synopsis of the Determination and Findings (B) mail notice of such brief synopsis to owner(s) of the Parcel (and/or their attorney of record) and (C) take all steps appropriate to comply with applicable provisions of the EDPL and all other applicable laws, rules or regulations to implement this Resolution.

DETERMINATION AND FINDINGS OF THE CITY OF YONKERS ADOPTED PURSUANT TO SECTION 204 OF THE NEW YORK EMINENT DOMAIN PROCEDURE LAW FOR THE ACQUISITION OF CERTAIN REAL PROPERTY LOCATED AT 76 A/K/A 70 FERNBROOK STREET A/K/A 8 WATER GRANT STREET (SECTION 1, BLOCK 615, LOT 1) IN THE CITY OF YONKERS, WESTCHESTER COUNTY, NEW YORK COMPRISING A LEASEHOLD INTEREST ON ONE (1) LOT.

Overview and Background

The City of Yonkers (hereinafter referred to as the "City") is a municipal corporation with the authority, pursuant to subdivision 2 of Section 20 of the General City Law of the State of New York, as amended (hereinafter called the "Legislation"), to take real property, either within or outside the limits of the City's boundaries, required for any public purpose.

The City desires to exercise its power of eminent domain, if necessary, for the "acquisition" of a leasehold interest in certain "real property" (as such quoted terms are defined in the New York Eminent Domain Procedure Law, herein the "EDPL") located in the City of Yonkers, Westchester County, New York and comprising the leasehold interest of All County Bus, LLC ("All County Bus") to the parcel located at 76 a/k/a 70 Fernbrook Street (a/k/a 8 Water Grant Street), City of Yonkers, Westchester County, New York and identifiable as Section 1, Block 615, Lot 1 (the "Parcel"), all in connection with a certain "public project" (as such quoted term is defined in the EDPL; and collectively referred to herein as the "Project") consisting of facilitating the productive reuse and redevelopment of the Parcel, (one of eight (8) total adjoining parcels (the "Park Site"), to which fee title was purchased by the City in February 2024, for fair market value, but subject to the existing leasehold) through the undertaking of (A) environmental remediation of the Park site, and (B) structural improvements for climate resiliency, and (C) the reuse and redevelopment of the Park Site as a waterfront public park, including playground and recreational facilities, pursuant to the EDPL, all in connection with serving the public use, benefit or purpose described herein.

In addition, the Project is consistent with the goals of and will complement and advance the public purposes envisioned by Connections: The Yonkers Comprehensive Plan, adopted September 2000 ("Comprehensive Plan") as well as the Ludlow Master Plan, adopted November 22, 2022 by Resolution No. 144-2022 affecting the area immediately adjacent to the Park Site.. Improving, maintaining and expanding parks, recreation facilities, and programs and activities in the southwestern areas of the City and along the waterfront, formerly limited to industrial uses, for the City's residents and, especially for the youth of the City, is one of the focus areas of the Comprehensive Plan. Furthermore, the southwestern waterfront area was a strategic site identified under the Comprehensive plan and the focus of redevelopment activities at the Park Site. Said redevelopment activities, which entail reclaiming properties currently limited to industrial uses for reuse and redevelopment projects that will have a positive benefit

to the surrounding community which meets the needs of the adjacent residential neighborhood and offers a connection to and between the downtown area of the City, the City waterfront along the Hudson River, and the Greenway Trail. Thus, the acquisition of the Parcel in connection with the Project is fully consistent with the Comprehensive Plan and the Ludlow Master Plan. In addition, the acquisition is within the City's statutory authority and will fulfill its statutory purposes.

In order to complete the Project, it may be necessary for the City to exercise its power of eminent domain if a voluntary transfer of the Parcel is not consummated. No alternative locations exist in the City that are being considered for the Project.

The Public Hearing and Comment Period

In accordance with the EDPL, on March 25, 2025 at 6:30 p.m., a duly noticed public hearing (the "Hearing") was held in the City Council Chambers located at Yonkers City Hall, 40 South Broadway, in the City, to inform the public and to review the public use, benefit or purpose to be served by the Project, the proposed location of the Project and its general effect on the environment and the residents of the locality where the Project is proposed to be constructed. At the Hearing, the public was provided an opportunity to provide any comments and a record of the Hearing was made, including written statements submitted at or prior to the Hearing, and was provided to the members of the City Council.

The comments received during the Hearing, which were mostly supportive of the City's acquisition for establishment of a public park, have been reviewed, made part of the record and accorded full consideration by the City. The EDPL does not require that the City address in its determination and findings any specific concern or objection raised at the Hearing. The City's responses to certain of the comments that were received during the Hearing are summarized below, and in some cases as more fully set forth in the determination and findings:

- (i) In response to the comment expressing concern over the loss of jobs to citizens of the City and the displacement of a local business, the current leaseholder, All County Bus, LLC, has already entered into a lease agreement for office space within the City, and intends to lease garage and storage space from Liberty Lines Transit, also within the City.

EDPL Section 204

At a duly noticed and scheduled meeting in addition to the above findings, the City makes the following specific determination and findings (collectively with the foregoing, the "Determination and Findings") concerning the Project pursuant to EDPL Section 204:

- I. The Public Use, Benefit or Purpose To Be Served by the Project [EDPL § 204(B) (1)].

The proposed acquisition of the Parcel in connection with the undertaking of the Project will serve a public use, benefit and/or purpose because it will advance the overall general prosperity and economic and social welfare of the residents of the City by returning the underutilized and derelict Parcel to productive use and by attracting and accommodating appropriate and allowable development and end user(s), and thereby, among other things, (i) allowing for the provision of additional and much needed public park and open green space and allowing for safe, welcoming and convenient access to recreation amenities for the residents of the City and the general public thereby to promote their health, safety, wellness and general welfare, (ii) create employment opportunities, (iii) combat economic stagnation at the Parcel through stimulating, promoting and/or supporting new and/or existing economic revitalization and redevelopment efforts, (iv) decrease the negative impacts associated with large vacant buildings within the City, (v) enhance the overall functionality and/or attractiveness of the area and surrounding area, (vi) as appropriate, may include, but not limited to, compliment and/or advance any public purpose contemplated by the Comprehensive Plan[and the Urban Renewal Plan].

II. Location of the Project and Reasons for Selection of that Location [EDPL § 204(B)(2)].

The location of the Project is in the City and identifiable by the following street addresses and tax identification numbers: leasehold interest to All County Bus, for the parcel located at 76 a/k/a 70 Fernbrook Street (a/k/a 8 Water Grant Street), City of Yonkers, Westchester County, New York and identifiable as Section 1, Block 615, Lot 1. Such location was determined based upon information in the Comprehensive Plan, the Ludlow Master Plan, the Hudson River and potential of providing open green public park space and its potential for continuing to spur economic revitalization and redevelopment in the surrounding areas of the City. No alternative locations exist in the City that are being considered for the Project.

III. General Effect of the Project on the Environment and Residents of the Locality [EDPL § 204 (B)(3)].

By resolution of the City Council, duly adopted on December 10, 2024 (the "City SEQRA Resolution") and the completed Full Environmental Assessment Form ("FEAF"), including Parts 1, 2 and 3 of the FEAF and the attachments thereto, the City Council, pursuant to the New York State Environmental Quality Review Act, Article 8 of the New York Environmental Conservation Law and the regulations promulgated thereto at 6 N.Y.C.R.R. Part 617 (collectively known hereafter as "SEQRA"), having found that the Project constituted a "Type I" action (as that term is defined in SEQRA) and conducted a coordinated SEQRA review of the Project, further concluded that the Project will not result in a potential significant adverse environmental impact. Such determination of the City Council constituted the adoption of a Negative Declaration which required no further review or action pursuant to SEQRA with respect to the Project. The City SEQRA Resolution and the FEAF, together with any other documents and information on which it was based, is incorporated herein by reference and is made a part hereof.

In sum, the City Council concluded that the Project, including the acquisition of the Parcel, will not result in a potential significant adverse impact on the environment. The acquisition of the Parcel and the completion of the Project will positively impact the residents of the City, thereby expanding the benefits of the City's parks and recreation areas, advancing the creation of additional job opportunities, and otherwise supporting the general prosperity and economic welfare of the City's residents.

IV. Other Relevant Factors [EDPL § 204 (B)(4)].

The City has given due consideration to the Hearing record including, but not limited to, comments received during the Hearing. In addition, the City has taken into account public opinion and concerns, if any, expressed through the SEQRA process associated with the Project. If a voluntary transfer of the Parcel cannot be consummated by the City, then the City may proceed with condemnation of the Parcel in connection with the undertaking of the Project.

Conclusion

Based on due consideration of the foregoing, the City hereby makes its Determination and Findings in accordance with the EDPL in connection with the acquisition of the Parcel by condemnation, if necessary, in connection with the undertaking of the Project.

CONTAMINATING BATTERY ENERGY STORAGE SYSTEMS THROUGHOUT
WESTCHESTER COUNTY

WHEREAS, The City Council of the City of Yonkers (the “City Council”) has
long been concerned with the impact of battery energy storage systems (“BESS”) on, among other things, surrounding properties, neighborhoods, the environment, and public health and safety.

WHEREAS, BESS are a relatively new technology that could serve an
important role in facilitating the production and use of clean energy.

WHEREAS, However, there are issues and concerns related to the safety,
security and externalities of BESS, including fire, chemical release, standard energy hazards, and noise.

WHEREAS, the City of Yonkers and other responsible municipalities are
carefully studying BESS in order to implement appropriate regulations to mitigate or
avoid the negative impacts of BESS as necessary to protect public health, safety,
and quality of life for their residents.

WHEREAS, Yonkers is the largest City in Westchester County and desires to
create and implement appropriate comprehensive county-wide regulations for
BESS.

WHEREAS, the Westchester County Department of Health is charged with
protecting, maintaining and improving the overall health safety and welfare of all the
residents of Westchester County.

WHEREAS, over the years the County has produced and enforced safety
standards for many substances and facilities including but not limited to Toxic
Substances, Lead, Radon, Mercury, Hazardous waste, Radiological Health and

Bulk Petroleum Storage.

WHEREAS, currently, County Environmental health professionals investigate potential exposures from environmental contaminants at inactive hazardous waste sites and from petroleum and chemical spills, fires and other environmental incidents.

WHEREAS, Annually, the Westchester County Department of Health regularly has responded to hundreds of chemical and toxic spills throughout the County.

WHEREAS, moreover, The County Chemical Emergency Response van enables the Westchester County Department of Health to respond on a 24-hour basis to numerous chemical emergencies and hazardous spills, making available a high level of specialized knowledge and technology county-wide.

WHEREAS, the mental health and well being of people in the City of Yonkers is a vital issue that affects not only the quality of life, but also the health of communities, families, and economic stability; and

WHEREAS, approximately one in five adults in the nation (52.9 million persons in 2020), experience a diagnosable mental health condition such as depression, anxiety bipolar disorder, schizophrenia, or post-traumatic stress disorder, in a given year; and

WHEREAS, for approximately one in 25 adults in the nation, a serious mental illness dramatically affects the person's ability to perform major life activities; and

WHEREAS, persons with serious mental illness face an increased risk of having chronic medical conditions and, on average, die 25 years earlier than others due largely to treatable medical conditions; and

WHEREAS, an estimated 26% of homeless adults in the nation who stay in shelters live with serious mental illness, and a little more than 50% of adults who experience a substance use disorder also have a concurring mental illness; and

WHEREAS, approximately one in five youths 13 to 18 years of age, experience a severe mental disorder at some point in their life and, for children eight to fifteen years of age, the estimate is that 13 % will experience a severe mental disorder, and

WHEREAS, the prevalence of serious mental illness is reported to be higher among woman than men; and

WHEREAS, mental illnesses, such as depression, are the third most common cause of hospitalization in the nation for persons 18 to 44 years of age; and

WHEREAS, despite the widespread existence of mental illness there is nonetheless a stigma attached to the illness; and

WHEREAS, treatment can be effective and recovery possible for mental illness, yet

millions of Americans still do not receive the mental health care they need, with only 41% of adults in the nation with a mental health condition and just over half of children eight to fifteen years of age needed mental health `services; and

WHEREAS, amyotrophic lateral sclerosis, or ALS, and known by many as Lou Gehrig's disease, is a progressive fatal neurodegenerative disease that attacks nerve cells in the brain and spinal cord; making even the simplest movements - walking, speaking, gesturing - nearly impossible; and

WHEREAS, approximately 30,000 individuals in the United States are afflicted with ALS at any given time, with more than 6,000 new cases appearing each year; and

WHEREAS, approximately 15 new cases of ALS are diagnosed every day, with a person losing their battle with the disease every 90 minutes; and

WHEREAS, the average life expectancy of a person with ALS is two to five years from the time of diagnosis; and

WHEREAS, ALS strikes people regardless of race, sex, age, or ethnicity; and

WHEREAS, finding the causes of, and cure for, ALS will prevent the disease from robbing hundreds of thousands of Americans of their dignity and lives; and

WHEREAS, aggressive treatments of the symptoms of ALS can extend the lives of those living with the disease; and

WHEREAS, Patrick Quinn, a native and resident of the City of Yonkers who was diagnosed with ALS in 2013, co-founded the famous ALS Ice Bucket Challenge with his friend and fellow ALS campaigner Pete Frates; and

WHEREAS, the ALS Ice Bucket Challenge was a tremendous event that raised \$115 million in the summer of 2014 that brought awareness to the devastating disease and helped spur a large increase to the ALS Association's budget to conduct important and impactful research; and

WHEREAS, on December 9, 2019, Pete Frates unfortunately passed away from the disease at the age of 34; and

WHEREAS, on November 22, 2020, Patrick Quinn also unfortunately passed away at the age of 37; and

WHEREAS, their legacy will live on in the hearts of the ALS community, and their tireless work to advance research will never be forgotten so that one day, we can create a world without ALS; and

WHEREAS, Patrick Quinn's legacy will forever live on in the City of Yonkers, and his inspiration and courage in his tireless fight with ALS will never be forgotten; and

WHEREAS, raising public awareness of this disease can facilitate the discovery of a cure, and bring much needed attention and dollars for support and services for families in New York State and the City of Yonkers that are dealing with ALS; and

WHEREAS, the month of May has been designated as National Amyotrophic Lateral Sclerosis Awareness Month since 1992, when the United States Senate passed Joint Resolution 174, and has since been observed nationwide year, with events designed to promote research and provide improved support for those coping with the disease and the families who care for them;
