RESOLUTION APPROVING AMENDMENT OF THAT CERTAIN INTER-MUNICIPAL AGREEMENT BETWEEN THE CITY OF YONKERS AND THE COUNTY OF WESTCHESTER RELATED TO THE JFK MARINA TO INCLUDE THE FUNDING OF CERTAIN IMPROVEMENTS TO THE HUDSON RIVER MUSEUM.

WHEREAS, on or about December 16, 2008, the County and the Municipality entered into an Inter-Municipal agreement ("IMA") whereby the County agreed to, inter alia, provide funding to the City for the design of an amphitheater, parking structure, and improvements to JFK Memorial Drive; and

WHEREAS, the City and the County duly executed a first amendment on April 12, 2011; and

WHEREAS, the City and the County duly executed a second amendment on October 23, 2019 which removed certain road and parking improvements and added improvements to the Museum's West Wing and Glenview Historic Home ("Museum Projects"); and

WHEREAS, the County now wishes to further amend the IMA to amend the IMA from \$12,283,000 to \$14,202,276.87; and

WHEREAS, the County will provide the City with an additional \$227,925; and

WHEREAS, the Engineering Department has already budgeted additional funds in the Capital Budget; and

WHEREAS, New York State General Municipal Law Article 5-G, Section 119-o, authorizes municipal corporations and districts to enter into agreements for the performance of various functions; and

NOW, THEREFORE, BE IT RESOLVED, that the City is authorized to enter into an IMA with the County of Westchester to enter into a third amendment of the JFK Marina IMA between the County of Westchester and the City of Yonkers in order to amend the total amount of the Project and increase the amount of funding from the County; and be it further,

RESOLVED, that a review pursuant to the State Environmental Quality Review Act ("SEQRA") and its implementing regulations, 6 NYCRR Part 617, was conducted as required by the original IMA, and the above change in scope and a File Number: TMP-0507

The City of Yonkers hereby ordains and enacts:

Section 1: The County of Westchester has authorized additional funding of \$ \$227,925, to the City of Yonkers, towards improvements to be made to the Hudson River Museum pursuant to that Certain Intermunicipal Agreement between the City and the County.

Section 2: The Mayor of the City or his authorized designee is hereby empowered to execute any and all instruments and take such other actions as may be necessary to effectuate the purposes hereof.

Section 3: The City's Grant Budget for fiscal year 2025/2026 is hereby amended by increasing revenues and appropriations for the Hudson River Museum, as follows:



WHEREAS, there is pending before the City Council of the City of Yonkers (the "City Council"), a proposed local law authorizing the sale of property owned by the City of Yonkers (the "City") located in the State of New York, County of Westchester, and City of Yonkers known as 164 Ashburton Avenue and designated on the Official Tax Map of the City as Section 2, Block 2041, Lot 38, (the "Property"); and

WHEREAS, pursuant to Article 8 of the New York Environmental Conservation Law, as amended, and the regulations promulgated pursuant thereto by the Department of Environmental Conservation of the State of New York, as amended (collectively, "SEQRA"), the City Council must review the proposed action, which consists of the sale of the Property (the "Proposed Action") in accordance with SEQRA; and

WHEREAS, the City Council has determined that the Proposed Action is classified as an Unlisted Action, as defined by SEQRA; and

WHEREAS, the City Council has carefully reviewed and considered the Proposed Action, the documentation related to the Proposed Action, including the Environmental Assessment Form ("EAF"), and the criteria set forth in Section 617.7 of 6 NYCRR Part 617 under SEQRA and has identified and carefully considered the relevant areas of environmental concern, as more fully set forth in the EAF, to determine whether the proposed action will have a significant adverse impact on the environment.

NOW, THEREFORE, BE IS RESOLVED by the City Council, that based upon the City Council's review of the EAF and for the reasons set forth therein, the City Council hereby adopts a Negative Declaration under SEQRA, finding that the adoption of the local law authorizing the Proposed Action will have no significant adverse environmental impacts; and be it further



LOCAL LAW AUTHORIZING THE CONVEYANCE OF THE FORMER PUBLIC SCHOOL #12 TO DAR HOLDINGS 164 LLC FOR THE REDEVELOPMENT OF SAID PROPERTY

Be it enacted by the City Council of the City of Yonkers, as follows:

Section 1. General City Law Section 23 and Second Class Cities Law Section 37 are hereby superseded to the extent herein, provided as follows:

DAR HOLDINGS 164 LLC, 10075 (hereinafter referred to as "DAR HOLDINGS") has expressed an interest to the City of Yonkers in redeveloping the former public school # 12 located at 164 Ashburton Avenue, Yonkers, New York, and identified on the Official Tax Map of the City of Yonkers as Section 2, Block 2041, Lot 38 (hereinafter the "Premises"), and which property is not currently being used nor has it been designated for specific use in the future nor can it be utilized by the City of Yonkers for its intended municipal purpose and is thereby considered surplus; and

The City Council of the City of Yonkers hereby authorizes the Mayor to execute a contract of sale containing substantially the same terms and conditions as set forth below with DAR HOLDINGS for the sale and development of the Premises which is planned to be redeveloped to residential housing (the "Improvements"). The terms and conditions as set forth below are hereby approved by the City Council, as the redevelopment of this property as stated hereinabove would be in the best interest of the City.


Section 2. The consideration for this sale will be Five Hundred Thousand Dollars (\$ 500,000.00), subject to the following express terms and conditions:

- 1. The property and all improvements situated thereon shall be conveyed on an "as is" basis.
- 2. DAR HOLDINGS shall deposit the sum of Fifty Thousand Dollars (\$50,000.00) as an initial deposit upon its execution of the contract of sale.
- 3. DAR HOLDINGS shall be required to pay all applicable city and state transfer taxes.
- 4. The Mayor or his authorized designee shall negotiate such other terms and conditions which are in the best interest of the City of Yonkers.

WHEREAS, the City of Yonkers (the "City") owns or is authorized by a judgement of foreclosure to dispose of the property listed in APPENDIX A - THE PROPERTY, which is attached hereto (collectively, the "Property"); and

WHEREAS, the City is not using, no longer needs, and cannot develop the Property for any current or intended municipal purpose, therefore the Property is deemed surplus; and

WHEREAS, as the Property is surplus, the Mayor is authorized to dispose of the Property by private sale or auction, subject to the upset prices set forth in Appendix A, receipt of required approvals, and compliance with applicable law; and

WHEREAS, disposing of the Property will benefit the City by, among other things, generating revenue, returning the Property to the tax roll, decreasing expenses and liabilities, mitigating blight, and returning the Property to productive use; and

WHEREAS, disposal of the Property is expressly conditioned on the preservation of any required easements and any further conditions that are in the best interest of the City; and

WHEREAS, the Mayor or his authorized designee may execute any documents necessary to carry out the purpose of this Resolution.

NOW, THEREFORE, BE IT RESOLVED, that disposal of the Property by the City in accordance with this Resolution is hereby authorized and approved; and be it further

RESOLVED, that the action proposed by this Resolution is classified as a Type II action under the New York State Environmental Quality Review Act ("SEQR") and therefore requires no further review under SEQR; and be it further

RESOLVED, that this Resolution shall be effective immediately.
